



## Foster Agreement

- 🐾 I agree that I am over 21 years of age.
- 🐾 I understand that I may be required to provide foster care to my foster animal for an extended and indefinite period of time
- 🐾 I agree to provide an FLH representative access to all parts of my home and property for a home inspection before my application to foster is approved. If approved, I also agree to provide an FLH representative access to my home and property to check on my foster animal, at any time that I am in possession of my foster animal.
- 🐾 I understand that FLH provides NO GUARANTEE as to the health of my foster animal and that my foster animal may have medical needs, socialization problems, and may not be housebroken.
- 🐾 I agree to provide my foster animal with veterinary care as authorized by FLH. I will not arrange or pay for any elective veterinary care for my foster animal without the express consent of an authorized FLH representative.
- 🐾 I will take all necessary precautions to prevent my foster animal from either impregnating another animal or becoming impregnated. In the event that happens, I will notify FLH immediately.
- 🐾 I understand that I may only have my foster animal temporarily.
- 🐾 I agree that I am fostering this animal for FLH and that I do not have any right of ownership over my foster animal. I further agree that FLH's rights in and to my foster animal are superior to mine.
- 🐾 I agree to immediately return any foster animal in my care to FLH at the request of its authorized representative at any time and for any reason.
- 🐾 If FLH is forced to undertake legal action to enforce any provision of this agreement, I agree to indemnify FLH for all court costs and attorney fees connected with such an action.
- 🐾 If I am planning to move at any time during the period when I am housing a foster animal, I agree to contact FLH prior to my move and provide FLH with my new contact information.
- 🐾 **HOLD HARMLESS/INDEMNIFICATION:** Fur Love Haven (FLH) and its Officers, Board of Directors, Volunteers, Affiliated Entities and/or agents shall not be liable to foster on any theory of legal liability including but not limited to the negligence of FLH (and its Officers, Board of Directors, Board of Directors, Volunteers and/or agents) for any injury, death or damage directly or indirectly caused by this animal. Foster does hereby release FLH (and its Officers, Board of Directors, Volunteers and/or agents) from any and all liability,

claims, suits, obligations, demands or causes of action, known or unknown, foreseen or unforeseen.

By submitting the Foster application, you are agreeing that:

1. I have completely read the Foster agreement and understand all questions on the application.
2. I understand that this animal MUST be indoors and will not be chained/penned outside.
3. I further understand that if for any reason I want to give up this animal, I will email Fur Love Haven and undergo a 14-day waiting period in which a representative from the organization will work with me to resolve any issues with the animal.
4. I also understand that a representative from the organization may visit the animal to ensure that it is well taken care of; if we find that the animal has been neglected or abused in any way or for any reason, we reserve the right to remove the animal from the premises. Your application submission authorizes us to do so as necessary.
5. I authorize Fur Love Haven (FLH) to contact:
  - 🐾 My veterinarian(s) to check the care provided to previously and/or current pets, and to check the spay/neuter history;
  - 🐾 My landlord to ensure that I have his/her/its permission to keep pets on the premises; and
  - 🐾 My employer to confirm employment
